## **Abstract**

### Traceable Traditions mentioned in the interpretation of the Holy Qur'an: collecting, expounding, and studying

The research tackles the collection of Traditions stated explicitly by the Prophet in interpreting the Quranic verses, in addition to studying it in details from the perspective of Tradition. The importance of this topic is quite clear in the following:

- 1- The supreme position that this topic acquires, as it is related to Allah's Book and His Prophet's Sunnah (Peace be upon him), that are the first two sources of Islamic legislation.
- 2- Vitality of the topic, as it discusses the interpretation of the Word of Allah via his Prophet's Sunnah (Peace be upon him). This concerns every Muslim, especially scholars because there is no Muslim doesn't read or listen to verses of Allah's Book every day and night. Al-Imam Al Tabari Said "I wonder of those who read Qur'an without learning its interpretation, how could they enjoy such reading".
- 3- Reference to the prophetic narrations in explaining the meaning of the Word of Allah is the best and nearest way for understanding verses properly.

#### Topic Objectives

- 1- Making a connection between the Islamic nation and its Allah's Book through the apostle of true religion, the best jurist and scholar of Allah's Book.
- 2- Collecting prophetic narrations in the interpretation of the word of Allah, together with tackling them in a detailed study based on rules and principles of the scholars of prophetic tradition.
- 3- Making a distinction between the valid and invalid narrations in explicit interpretation by the Prophet (peace be upon him).
- 4- Knowing the volume of verses that its explicit interpretation was mentioned in the prophetic Sunnah.
- 5- Extracting the useful result concerning the proportion of weakness in interpretation traditions as it was known that the majority of interpretation traditions are weak.
